34TH ANNUAL COUNCIL MEETING

Oklahoma City, Oklahoma

Embassy Suites – Will Rogers World Airport

September 17, 2022

The 34th Annual Council of the Continental Society Daughters of Indian Wars (CSDIW) was called to order at 9:02 a.m. by Governor General Helene Werner.

Chaplain General Frances Jakes gave the Invocation. Historian General Betsie Gricar led the Pledge of Allegiance to the Flag of the United States of America. Corresponding Secretary General Ann Waggaman led the American's Creed. Registrar General Jessieanne Wells led the Salute to the Banner of the Continental Society Daughters of Indian Wars. First Deputy Governor General Betty Samaras read the Objects of the Continental Society. Librarian General Deborah Hicks read the Colors of the Wind.

Governor General Helene Werner recognized Mary Armstrong who made the presentation of the Calumet.

Following the passing of the Calumet, Oklahoma Governor Kathy Gazzam gave the official Welcome from the Oklahoma Society. First Deputy Governor Betty Samaras gave the official Response from the Society.

Governor General Helene Werner recognized the Honorary Governors General in attendance to bring greetings: Shelby Dean Ward, 2012-2014, and Karen Kurth Hall, 2014-2016.

The Credentials Report was given by Norma Hughes, Credentials Committee Pro Tem. A quorum was present with a voting strength of **42**.

Recording Secretary General Mari Noorai called the Roll; the following were in attendance: Helene Kirby Werner, Governor General; Betty Keener Samaras, First Deputy Governor General; Carol Mayo Steakley, Second Deputy Governor; Frances Becton Jakes, Chaplain General; Mari Noorai, Recording Secretary General; Barbara 'Ann' Waggaman, Corresponding Secretary General; Rebecca Eisenman, Organizing Secretary General; Shirley Jean K. Arendt, Treasurer General; Jessieanne Houck Wells, Registrar General; Betty 'Betsie' Gricar, Historian General; Deborah Ann Whitmore Hicks, Librarian General; Shirley Vanderbeck, PRP, Parliamentarian; Awards Chairman, Lora McDaniel; Calumet Chairman,

Following the Roll Call, Governor General Werner reported the total voting strength of 42, and she declared a quorum was present for the transaction of business.

Norma Hughes, as Credentials Chairman Pro Tem, moved for the adoption of the Credentials Report; no second was needed since the motion came from a Credentials Committee. Governor General Werner declared the motion adopted following a voice vote.

Governor General Werner recognized Norma Hughes for handling Registration for the 34th Annual Council.

Governor General Werner recognized the Continental Officers and Officer by Appointment in attendance. She recognized leaders from other patriotic and hereditary organizations present and those 14 members who were attending their first Annual Council.

Following introductions, Governor General Werner awarded members who have gone above and beyond in their service to the Continental Society with the Governor General's Certificate of Appreciation, as follows:

- Christie Noble of Iowa for her gift of 52 back issues of the *Calumet*, which have all been scanned and uploaded to the Members Only website by our webmistress.
- Beverly Baker of Georgia for her and her team's efforts to keep the Society's website updated and professional in appearance, as well as creating all needed forms.
- Joan Bogaty and Karon Jarrard, both of California, for tirelessly keeping the membership informed through the *Calumet* and Yearbook.
- Leslie Richards, Scholarship Chairman, for her efforts in locating two deserving scholarship recipients. Kimberly Nagy, MAL Chairman, for constant support and efficiency.

Governor General announced adjustments to the Meeting Program's schedule. Betty Samaras moved for the adoption of the Meeting Program with corrections; the motion was seconded by Barbara Allison. Governor General Werner declared that the motion passed by voice vote and the Meeting Program was adopted with corrections.

The Minutes of the March 31, 2022 Spring Board Meeting was approved by committee and published in the *Calumet*. The Minutes of the March 31, 2022 Spring Board Meeting were filed as printed.

Recording Secretary General Mari Noorai presented the three Recommendations from the Executive Board.

1. The Executive Board recommended that all bills of the Continental Society be paid. Recording Secretary General Noorai moved the adoption of the recommendation; Governor General Werner declared the recommendation adopted following a voice vote.
2. The Executive Board recommended that all acts of the Executive Committee and business conducted from 31 March 2022 to 15 September 2022, including all electronic meetings, be affirmed, ratified, and approved by the members and made effective as official actions of the organization. Recording Secretary General Noorai moved the adoption of the recommendation; Governor General Werner declared the recommendation adopted following a voice vote.
3. Treasurer General Shirley Arendt presented the proposed Budget for 2022-2023 and conducted the discussion and explanation. Treasurer General Arendt moved that the recommendation by the Executive Committee to accept the proposed Budget for 2022-2023 be adopted; Governor General Werner declared the recommendation adopted following a voice vote.

Governor General Werner appointed Jillian Mueller, Tammy Mouliere, and Barbara Fincher to approve the Minutes of the 34th Annual Council.

Governor General Werner appointed Susan Moritz as Timekeeper.

Reports of the Officers General, Appointed Officers General, Committee Chairmen, and State Governors were given; the reports of those not in attendance were filed.

Following the reports, Governor General Werner thanked all for their service and dedication to the Society. The meeting was recessed at 10:40 a.m. for the Annual Council Luncheon at 11:30 a.m.

Governor General Werner resumed the meeting at 11:25 a.m., welcoming all to the 34th Annual Council Luncheon. She recognized all General Officers.

Governor General recognized the Oklahoma State Society for their diligent work to make the Annual Council a success. She recognized Oklahoma State Governor Kathy Gazzam, Reservations Chairman Norma Hughes, and Oklahoma State Society Hospitality Committee members: Libby Hayes, Diane King, Janice Mitchell, Gina McCasland, Barbara McMullin, and LaNell Shores.

Chaplain General Frances Jakes gave the Blessing for the luncheon. During the luncheon, Susan Howard, a prospective member, performed instrumental Native American music.

Governor General Werner recessed the meeting at 12:33 p.m. Chaplain General Jakes conducted the Memorial Service.

The 34th Annual Council resumed at 6:25 p.m.

Chaplain General Jakes gave the Blessing; no rituals were repeated since they were completed during the morning meeting.

Governor General Werner reported that there was no Unfinished Business of the Society.

Oklahoma Governor Kathy Gazzam introduced the evening's speaker, Harvey Pratt, a Native American Artist, at 7:23 p.m. on the designated Native American War Memorial.

Following the program, the Business meeting was resumed at 7:55 p.m.

Governor General Werner reported that there was New Business, the Election and Installation of 2022-2024 Officers General. The Report of the Nominating Committee was printed in the June 2022 *Calumet*.

Mary Webster Glenn (TX) was nominated for the office of Governor General. There were no nominations from the floor, and the office was closed.

Lynda Moreau (LA) was nominated for the office of First Deputy General. There were no nominations from the floor, and the office was closed.

Jessieanne Wells (KY) was nominated for the office of Second Deputy General. There were no nominations from the floor, and the office was closed.

Mari Noorai (SC) was nominated for the office of Chaplain General. There were no nominations from the floor, and the office was closed.

Karon Jarrad (CA) was nominated for the office of Recording Secretary General. There were no nominations from the floor, and the office was closed.

Susan Moritz (MI) was nominated for the office of Organizing Secretary General. There were no nominations from the floor, and the office was closed.

Betsie Gricar (IN) was nominated for the office of Corresponding Secretary General. There were no nominations from the floor, and the office was closed.

Shirley Arendt (CA) was nominated for the office of Treasurer General. There were no nominations from the floor, and the office was closed.

Laura T. Allen (FL) was nominated for the office of Registrar General. There were no nominations from the floor, and the office was closed.

Lynne Schulman (DC) was nominated for the office of Historian General. There were no nominations from the floor, and the office was closed.

Joyve Wold (AZ) was nominated for the office of Librarian General. There were no nominations from the floor, and the office was closed.

Following the election of the slate of the Officers General, Governor General Werner declared the 2022-2024 Officers General elected by voice vote.

Honorary Governor Karen Hall installed the 2022-2024 Officers General.

Following the Installation, the Governor General Sash, Insignia, and CSDIW National Society Gavel was exchanged between outgoing Governor General Helene Werner to the incoming Governor General Mary Glenn.

Governor General Mary Glenn assumed the chair; Mrs. Werner was escorted from the room.

Shelby Ward moved that pursuant to Article VI Officers, Section 6 of the Bylaws, that Helene Kirby Werner be elected as an Honorary Governor General of the Continental Society Daughters of Indian Wars. Karen Hall seconded the motion. Governor General Glenn declared the motion adopted following a voice vote.

Following the vote, Mrs. Werner was escorted into the room, and Governor General Glenn recognized her election as Honorary Governor General.

Following Honorary Governor General Helene Werner's closing remarks, First Deputy General Betty Samaris presented gifts to outgoing Governor General Helene Werner on behalf of her Board. The Texas Society presented a gift to Governor General Glenn.

Susan Moritz moved that Helene Werner's name be removed from the CSDIW bank accounts, Mary Glenn's name be added, and the name of Shirley Arendt, Treasurer General, remain on the account. Adele Boyer seconded the motion. Governor General Glenn declared the motion adopted following a voice vote.

Governor General Glenn announced her project of supporting the United National Indian Tribal Youth (UNITY) with an emphasis on the individual Tribal Youth groups in various states, her Rising Sun pin, and her scripture Ephesians 4:3 "Make every effort to keep the unity of the Spirit through the Bond of peace." The Rising Sun pin was immediately available from Jillian Mueller (NV), and all Lineage Books brought to the 34th Annual Council were sold. All State Societies will receive handouts for the Governor General's Project

All newly elected Officers General were asked to meet for a short meeting and photograph immediately following the adjournment of the 34th Annual Council.

Governor General Glenn announced the 35th Annual Council would be hosted by Alabama Governor Martha Ann Whitt and Alabama State Society in Hunstville, Alabama, September 14-16, 2023. The speaker will be Butch Walker, presenting a program on Alabama Indigenous Tribes.

No other business came before the Annual Council.

Governor General Glenn announced that the 2023 Spring Board meeting will be held at the Army Navy Club in Washington, DC on Thursday, April 6, 2023 with additional information and registration to be published in the *Calumet*.

All Outgoing and Incoming Officers General were requested to see Shelia Beatty at the close of the Annual Council to sign the exchange sheet of the Sash and Insignia.

Governor General Glenn thanked all for attending the 34th Annual Council.

Chaplain General Mari Noorai gave the Benediction.

The 34th Annual Council was adjourned at 8:40 p.m.

OKLAHOMA COUNCIL SPEAKER

We were honored to have as our 34th Annual Council banquet speaker, Mr. Harvey Pratt, a Oklahoma Native American artist, who designed the National Native American Veterans Memorial, located on the grounds of the Smithsonian Institution's National Museum of the American Indian on the National Mall in Washington, D.C. Mr. Pratt has a 45 + year career as a forensic artist, working for over forty years in law enforcement, completing thousands of composite drawings and hundreds of soft tissue postmortem reconstructions.

"The National Native American Veterans Memorial will serve as a reminder to the nation and the world of the service and sacrifice of Native American, Alaska Native and Native Hawaiian veterans," said museum Director Kevin Gover, a citizen of the Pawnee Tribe of Oklahoma. "Native Americans have always answered the call to serve, and this memorial is a fitting tribute to their patriotism and deep commitment to this country." The outdoor exhibit is free to visit 24 hours a day, seven days a week.



Congress originally commissioned a national memorial for Native American veterans in 1994, a decade before the Museum of the American Indian was opened. In 2014, museum curators began conceptualizing the project - the first national landmark in Washington, D.C., to focus on the contributions of American Indians, Alaska Natives and Native Hawaiians who have served in the military – and in 2017, the museum launched an international design competition that drew 413 entries from five continents.

Harvey Pratt used in his design symbols that are universal among American Indian nations, including the cardinal directions, sacred colors and the elements of Earth. His "Warrior's Circle of Honor" design has as its

focal point an elevated stainless-steel circle that symbolizes the cycles of life and death as well as unity among Native veterans.

MEMBER AT LARGE CHAIRMAN - Kimberly O. Nagy, MD

The Continental Society currently has 61 members-at-large.

In the past year, 6 ladies have joined as members at large, and 3 have transferred to MAL status. One lady transferred to a chapter, one resigned, one was dropped for nonpayment of dues, and one was reported deceased.

It appears that there is a lot of interest in our Society as twenty-seven ladies were referred by the membership chairman. Applications and information about the application process was sent to all. All applications received by this chairman were reviewed prior to forwarding to the Registrar General.

Dues notices were sent and all dues payments were forwarded on to the Treasurer General. In response to the dues notice, \$1160 was received in donations and three ladies paid life memberships.

Of our 61 members-at-large, 34 are life members.

SCHOLARSHIP CHAIRMAN - Leslie Vander Meulen Richards

This year sixteen application packets were received, all arriving via postal mail as required and the first one received April 2, with several pushing the due date of June 15h. In all about 50 application packets were sent via email to those who stated interest in applying. This is larger than most earlier years in my various terms with this chairmanship. Nearly 100 emails were sent communicating with parents, schools, and prospective and actual applicants.

The states of residence of applicants were one each from WA, NC, NM, MA, AZ, SD, CO and ND. Two were from NE and six from OK. Eleven different indigenous tribes were represented: Seminole, Lumbee of NC, Comanche, Navajo, Chippewa, Choctaw, Wampanoag, Oglala Lakota, Omaha and Patawomeck of VA. Of the 16 applications received 4 were disqualified for being late or not meeting the minimum 3.0 gpa requirement.

Our first place winner is Miss Arizona Yellowfeather Carter of Leland, NC who is majoring in Social Work at the Un of NC at Wilmington. She is a member of the Lumbee Tribe of NC. You might want to visit lumbeetribe.com to learn about this tribe, one with which I was not familiar.

Miss Madison Moore of Brockton, MA, a member of the Mashpee Wampanoag Tribe, is our \$2,500 winner. Madison attends Curry College in Milton, MA majoring in nursing to be able to minister to the members of her tribe in their quest to gain better overall health thereby improving the quality of their lives.

Both of these young women, entering the junior year this fall, have stellar records of success in their scholarly lives as well as their amazing community service dedication. Additionally they come highly recommended by those with whom they interface.

This year many more inquiries about the scholarships and requests for the applications were received than in the past. I discovered late in the process that some were finding the application “on social media” or from some college financial aid departments. It became obvious from questions and the small number of actual applications received that not all were reading our website before requesting the packet or, after receiving it, they didn’t qualify. Revision of the print-ed/published materials for next year is already roughed out to be refined before next March when the new packet is published.

Please continue to encourage all members to donate to our very worthwhile scholarships. Not a single one of our applicants did not really NEED money and nearly every single one is an outstanding, deserving student. The more donations we have, the more money we can send to these struggling young people. It is very gratifying to hear from the students and learn of their dreams and plans to reach them. It would be wonderful if we could give assistance to every one! Thank you ladies for your donations and interest in the youth of the various indigenous tribal groups, they need us and they do so appreciate our help! I expect to have information from the two winners for our next *Calumet*. Madam Governor General it has been a pleasure and honor to serve the Society in your administration.

No current news from Alabama since the meeting in September in Oklahoma except we look forward to seeing you in Alabama in September 2023.

STATE NEWS

ARIZONA - Joyce Wold

The Arizona State Society meets in Phoenix once a year with the Hohokam Colony of New England Women and Arizona State Society Daughters of Colonial Wars, in May for our annual meeting. Since a majority of our members belong to all three organizations this works well for us. The three Societies rotate hosting and program responsibilities.

At the May 2022 Zoom Meeting, Governor Wold introduced a project for our State Society to help SAGU, American Indian College in Phoenix, AZ. Female Students will receive a small monetary gift to help with dormitory needs like cleaning supplies. etc. Most of the students work on General Education Degrees. Then return to their Reservation as teachers. This is a smaller less known local college with only 120 plus attending.

The Arizona Society gained new members by application.

Although we have missed getting together in person, conducting our meetings via Zoom has allowed our members in other states and all of Arizona to participate.

ARKANSAS - Governor Sharon S. Wyatt

Arkansas DIW met in person in Little Rock, Arkansas, August 4, 2021. We are 31 members strong and excited about our projects involving our indigenous brothers and sisters. Arkansas continues to monetarily support **Bacone College** in Muskogee, Oklahoma and **Sequoyah Research Center**, Little Rock, Arkansas.

Arkansas is in compliance with the National Society and the IRS having updated the wording in our state bylaws and regaining our 501 (c) 3 status.

Gaining new members brings new ideas and opportunities to fulfill our “object” – *“To strengthen our fellowship and to encourage cooperation between descendants of native and immigrant Americans.”* One of our most recent members, Belinda Jones, reported working along with her church, to provide water tanks for families in the Four Corners Community to improve living conditions on the Navajo Indian Reservation in Shiprock, New Mexico. Later in August, 2021, Jones reported the need for back packs and other school supplies. Through the efforts of Jones and other members of the Arkansas CSDIW, we have 40 back packs and over \$1000.00 worth school supplies to be delivered to the Oklahoma Indian Missionary Conference Immersion in October 2021. Three newspaper articles placed by Arkansas Publicity Chair Sheila Beatty, has increased donations and brought awareness to the current plight of the Navajo and Cherokee Nations.

Eight Arkansas CSDIW members attended the **Continental Society Daughters of Indian Wars Council** meeting held 18 September 2021 via ZOOM. Arkansas member Belinda Jones had the pleasure of introducing the keynote speaker Reverend Evelene “Tweedy Sombrero” Navarrete a United Methodist Minister who is full blood Navajo and ministers to the Navajo Nation in New Mexico.

Reverend Tweedy’s report of the basic needs of the indigenous peoples made me question – which third world country is she speaking of? Due to uranium mining, the accessible water is poisoned causing villagers to be forced to travel great distances to carry water back to their homes. The lack of water has intensified the suffering and deaths from covid 19. Reverend Tweedy further related the lack of electricity and internet access for children whose schools are closed. When asked what the number one dream was for her and the villagers, Reverend Tweedy replied, “a water truck”.

December 3, 2021 the Arkansas Society of the Continental Society Daughters of Indian Wars participated in the placement and dedication of 40 wreaths marking the newly found graves of Confederate soldiers buried in the historic Oakland Confederate Cemetery in Little Rock, Arkansas. Fourteen other Arkansas societies answered the call to help with this “Oakland Project”.

The cemetery known to be the final resting place of 900 unknown Confederate men and boys, has become the project of the General Robert C. Newton SCV Camp 197, based in Little Rock. A very meaningful program was presented by Camp Commander Randall Freeman.

Arkansas Society CSDIW was pleased to take part in the memorial for these soldiers providing four of the 40 wreaths needed at a minimal expense of \$10.00 each. Each wreath was decorated with red ribbons and poinsettias.

August 3, 2022, Arkansas State Society Registrar Christina Twardowski announced that our membership has increased to 39 with one application pending.

CALIFORNIA – Governor Karon Jarrard

Our only in-person meeting was the Annual Friendship breakfast held during Heritage Week in March 2022. It was a joint meeting with Daughters of Colonial Wars and New England Women.

We were honored to have Governor General Helene Werner attend September Council via Zoom and install 2022 - 2024 officers. Shirley Vanderbeck, PRP, is now State Governor.

FLORIDA – Governor Laura Allen

As we all know, the last 2 years have been challenging. Our Annual State Council normally takes place in Orlando in February along with several other societies. We were not able to meet in person but met via Zoom in February 2022. At that virtual meeting I was elected, installed by Honorary Florida Governor, Roberta Jordan and sashed as the new Governor for Florida. Bylaws Chair Becky West presented the proposed new amendments to our existing bylaws. Amendments were adopted. A nominating committee was also elected.

It was an honor and privilege to represent the Georgia Society in the re-dedication of a bronze marker on the grave of Colonel Benjamin Hawkins. The gravesite is located in Crawford County. The original marker was placed in 2015 by the Indian Springs Chapter in Jackson, Georgia. A floral wreath was also placed at Colonel Hawkins gravesite. Following the ceremony, a well-attended reception was held at the nearby Roberta Civic Center.

Several chapters continue to seek out historical sites and also deserving individuals to honor. This Governor is proud of their efforts and successes. All chapters are encouraged to submit articles in the Calumet.

As a state project, two lapel pins have been designed and now available for purchase. All proceeds will go toward the purchase of water tanks for The Navajo Nation. Our Ways and Means Committee plans to have a sales table at our January 2023 Annual Council meeting. The table will feature other unique items for purchase. Profits will also go toward The Navajo Nation Project.

Georgia Society continues to work toward increasing our membership. We are awaiting the approval of two other applications.

KENTUCKY – Governor Pat Godwin

This officer is Proud to inform you that we are 55 members strong. We gained two new members and continue working hard to increase membership and awareness.

The Kentucky Society meets twice a year with the Jamestown-Wilderness Rd Society and the Huguenot Society of the Founders of Manakin in the Colony of Virginian with meetings occurring in sequence.

Our Society has been using an imaginary peace pipe for our rituals. It was approved to purchase a peace pipe that will stay with the Kentucky Society. The pipe arrived in August and looks amazing. The pipe is a Native American Reproduction Eagle Head pipe and looks very authentic carved from wood decorated with beading and feathers.

Our Society voted and approved to donate money to the “Adopt an Elder” program. We are looking forward to making this an ongoing project.

Our Society had members donate goods (\$300 worth) and their time working in the Distribution Center at Hindman Settlement in Eastern Kentucky after the devastation of Flooding. They helped flood victim’s acquire food, personal hygiene items, home essentials, toys, books, and school supplies to the many families in need.

We have learned about the ways in which we can help the Native American today. We have also discussed the hardships that many Native Americans went through when put into orphanages. Discussion has also been about what we can do to help schools that support Native Americans and how to preserve the heritage.

This officer had the privilege to visit the Museum of Natural Resources in Washington DC in June, learning more about Native Americans and how they lived and used resources in the past. We are learning about our Historical past and continue to cherish the memories of our Native American Ancestors.

The Kentucky Society continues to work towards helping others in need and to promote and educate members about our Native and Immigrant Ancestors.

We are many working together as one.



LOUISIANA – Governor Linda P. Moreau

In July the Louisiana Society held a luncheon meeting with another heritage society. The Society voted to make a donation of \$200.00 to the General Scholarship Fund.

During the summer, this officer visited the Wichahpi Commemorative Stone Wall (also known as Tom's Wall) in Lauderdale County, Alabama. It is the largest unmortared rock wall in the United States and the largest memorial to a Native American woman. Each stone represents one step in the journey of a young Yuchi Indian woman, who walked back to her Alabama home after forcibly being removed to Oklahoma during the Trail of Tears.

Our officer elections for the next term will be held at our November meeting, which will be held at the historic home of one of our members.

We are happy to report that in the past year we have welcomed three new members (a 10% increase in membership for us) and we have a total of 32 members. We recently lost one member to death. Two more ladies are working on their papers. One application is currently pending at National. We have also had 14 supplementals approved, with 6 more currently pending at National.

It has been a pleasure to serve as the Louisiana Society Governor for the past 3 years.

At our summer meeting we had two 18-inch teepees displayed which were donated in 1995 by members, Georgeann Valentine and Margaret Carr.

Governor Mizell explained the use of extra feather pins for state officers that was suggested by the National Board in 2005. We were excited that member Sheri Horton, who has Native American ancestry, was able to purchase the Tee-pee pin.

NEVADA – Governor Barbara Youngman

This officer is proud and honored to have represented the Nevada State Society Continental Society Daughters of Indian Wars since taking office August 21, 2021 at our 4th Council Meeting.

Our 5th Council Meeting was held July 23, 2022 at the Las Vegas National Golf Club at which time we “shared” a Luncheon with the Las Vegas Chapter of the Daughters of the War of 1812 as the two groups have many members in common. We were able to conduct the business of both organizations and have a very nice luncheon. Yearbooks had been updated and were distributed.

A monetary donation was approved for the Pahrump, NV Powwow at our August council meeting. We also have some members serving on the Powwow Committee. Several Nevada Indian Wars members attended the Powwow in November, 2021, and even more plan to attend the upcoming event which will be held November 18-20, 2022. Pahrump, Nevada is the home to the Paiute and Western Shoshone tribes and the Pahrump Social Powwow gathers guests in a celebration of Native American traditions. The theme for 2022 is “Celebration of Youth” and the stated

purpose of the Powwow is creating a cultural and educational experience for all people through indigenous music, dance, craft, storytelling, and food.



Other activities include the donation of Thanksgiving baskets each year which include a turkey with roasting pan and a \$50 gift certificate for groceries to two families from the Southern Paiute Tribe. We join other lineage society groups to greet potential members at a genealogy fair at the Pahrump Valley Museum in November. We also will be sharing a traditional Turkey Dinner Buffet with the Nevada Southern Branch of National Society Sons and Daughters of the Pilgrims and the Samoset Chapter of the Colonial Dames of the 17th Century at the National Atomic Testing Museum on November 19, 2022.

OHIO – Governor Donna J Vanover

Our Ohio State chapter weathered the pandemic and is growing, learning about Native American history and culture and enjoying supporting the work of the Continental Society Daughters of Indian Wars.

Membership:

We happily report that as of May 1, 2022 Ohio has 50 members, 8 life members no deaths and no resignations. We are also have 3 applications with the Registrar General.

With growth in mind, the society has set up a professional style chapter email address that can be placed on a website or brochure allowing the same email address to be used to contact officers and they can conduct business even when the officers change. Our official email is CSDIW.Ohio@gmail.com. Our Registrar, Treasurer and Governor have access to this email.

Our service and knowledge is growing too:

In November, the Ohio chapter visited Sunwatch Village. A three acre active archeological site with a museum that celebrates Native American heritage activities. The site was the home to 100-500 Fort Ancient people who populated Southern Ohio from about 1000 to 1750CE.

The chapter made a donation of \$100 of books to the Build Your Own Library project from the friends of the Pine Ridge Reservation. The books were selected from a list provided on the web site; then purchased and delivered on/by Amazon.

In March, the Ohio chapter met at the Miamisburg mound. The estimated to contain 54,000 cubic yards of earth is the largest surviving conical mound. Built by the Adena 800B.C to 100A.D. people the mound was excavated in 1869 and found the site was built in several stages beginning with a burial at 24' and was later used for ceremonial purposes. Today there are steps that allow you to climb the mound.

The Ohio Society made a \$100 donation for equipment and supplies to the Oglala Lakota College Department of Nursing which provides an Associates of Science in Nursing degree. The school is accredited by the National League for Nursing Commission for Nursing Education Accreditation. They are asking for monetary donations for equipment and supplies.

Our October will be in Upper Sandusky at the historic Old Wyandot Mission and Cemetery founded John Stewart missionary to the Wyandot people. Kathy Dixon hostess.

Our current projects include:

- Collecting Coca-Cola bottle caps and carton labels to raise money for schools through the Coke Points program. The codes inside the caps and cartons are entered online and generate 5 cents per cap and 25 cents per carton for the designated charity. Chemawa Indian School is our designated recipient and a bin of caps and carton labels has been

collected to be entered for Chemawa. Members can easily enter their own caps in their spare time and support the school.

- Creating a brochure to distribute locally to historical and genealogical societies to bring increase membership.
- Looking in to a book collection for schools. Researching shipping costs/delivery costs.
- Looking in to a craft material collection. Researching shipping costs/delivery costs.

The Ohio Society held their Annual Council Sunday, 1 May 2022 at 2pm at the Grand Reserve Club House in Reynoldsburg, Ohio. This location was used during our organizational meetings. The meeting was successful with much business of the society accomplished.

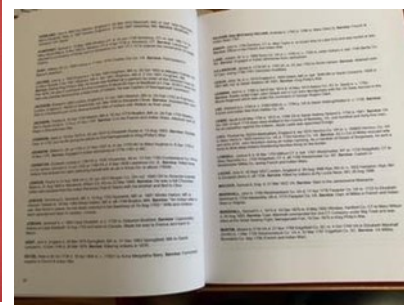
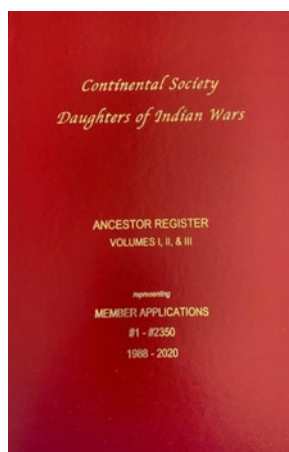

REQUIREMENTS FOR APPROVAL of an APPLICATION OR SUPPLEMENTAL

1. All names, dates and locations listed must be documented. Vital records are required for the first three generations (unless using an approved application from another society (see 5 below).
2. The link is vital. Each connection between generations must be documented.
3. Tradition or family lore will not be accepted as proof.
4. Undocumented sources will not be accepted.
5. Other organizations may have accepted application papers on the line presented, but CSDIW may not be able to accept it without proper documentation. Those organizations may have extensive libraries available to research application papers, but CSDIW does not. Approved papers from other societies may be accepted at the discretion of the Registrar. If submitting an approved application from another society, please do NOT list that society application as "proof" on the CSDIW application. Simply copy the proofs from the other approved application EXACTLY at each generation to the CSDIW application.
6. Please do not send extra proofs. One documented source is sufficient.
7. If an original document is difficult to read, it should be transcribed and the typed transcription attached to the copy of original document. Information from FindAGrave is not acceptable as proof unless it includes a CLEAR photograph of the gravestone in question.
8. Please underline only pertinent information with a red pen or pencil, using a ruler. No highlighters. Write the applicable generation number in the margin by the information. If you are unable to underline, place an arrow in margin pointing to pertinent information.
9. Applications will be not be processed from 2 April through 25 April of each year. The cutoff for the processing of applications will be three weeks before Annual Council.
10. Applications will be processed twice a month (perhaps sooner as time/volume allows). You must provide the telephone number/email address of each applicant.
11. If the Registrar General has any questions, she would like permission to email you and/or the prospective member. If this is acceptable, please inform her when you send the application and include the Registrar's email address.
 - a. **Always provide three (3) copies of the original application.** At least one must have original signatures in black ink.
 - b. Please provide the newspaper name, and page number from the newspaper banner. If not available please write the name of the newspaper and date.

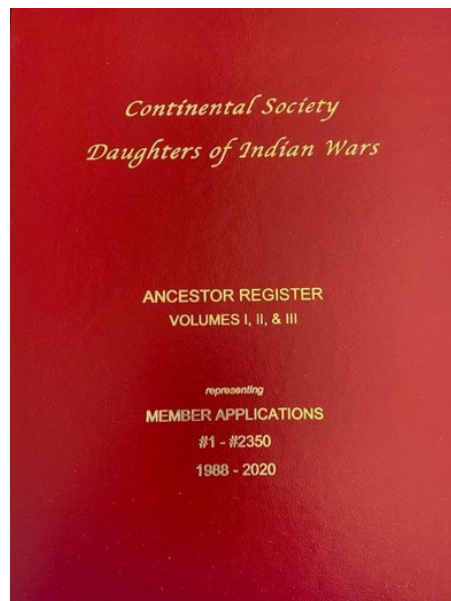
