CSDIW 35th Annual Council Meeting Minutes 16 August 2023, Huntsville, Alabama Tammy Mouliere-Recording Secretary Pro Temp

Governor General Mary Glenn called the 35th Annual Council Meeting to order at 9:01 a.m.

The Invocation was given by Chaplain General Mari Noorai. The Pledge of Allegiance to the Flag of the United States led by 1st Deputy Gov. Lynda Moreau. The American's Creed was led by Honorary Governor General, Helene Werner. Salute to the Banner of the Continental Society Daughters of Indian Wars led by 2nd Deputy Governor Jessianne Wells. The Object of the Continental Society read by Registrar General, Laura Allen. The Colors of the Wind read by Librarian General, by Joyce Wold

Governor General Mary Glenn reminded each of us of our Motto: "Our Handclasp of Friendship Shall Endure."

Curator General, Mary Armstrong, Presented the Calumet and it was passed around the room, each person holding the Calumet repeats "I come in Peace" and receiver repeating "I accept the peace" then returned to Mary Armstrong.

Governor General Mary Glenn welcomed all and introduced the Officers General:

Governor General Mary W. Glenn, 1st Deputy Governor General Lynda Moreau, 2nd Deputy Governor General, Jessianne Wells, Chaplain General Mari Noorai, Recording Secretary General, Karon Jarrard-Excused, Corresponding Secretary General, Betsie Gricar, Organizing Secretary General Sue Moritz, Treasurer General, Shirley Jean K. Arendt, Registrar General, Laura Allen, Historian General, Jackie-Lynne Schulman, Librarian General, Joyce Wold, Curator General, Mary Armstrong, Parliamentarian, Ora Jane Johnson, Assistant Registrar, Karen Janczy-Excused, Advisor, Helene Werner.

Governor General Mary Glenn welcomed our Advisory Board which is comprised of Honorary Governors General. Each was introduced and asked to bring greetings. Sarah "Sally" Wood Hlavay, Mrs. Joseph F. 2010-2012- and Cheryl "Cher" Miller Sesma, Mrs. Michael 2018-2020 were Absent. Shelby Dean Ward, 2012-2014 brought greetings, Karen Kurth Hall, 2014-2016 thanked Alabama and brought greetings, Ann Scott Garner 2016-2018 brought greetings, and Helene Kirby Werner, Mrs. Robert 2020-2022 brought greetings. Governor General thanked them.

Governor General Mary Glenn recognized leaders of other patriotic and hereditary organizations, who are members of the Continental Society: Ann Scott Garner for the House of Wessex and Colonial Clergy, Deborah Hicks for the Nat'l Soc. Sons & Daughters of Antebellum Planters, and Lynda Moreau for William the Marshall.

Governor General welcomed 13 first timers who were attending their first Annual Council.

Our official Welcome was given by Alabama State Governor, Martha Ann Whitt. The Response was given by First Deputy Governor, Lynda Moreau to Thank the State of Alabama.

Governor General Mary Glenn gave special recognition to some who, during her term, had given above and beyond service to this Continental Society. Beverly Baker of Georgia. Beverly and her team for keeping our website very appealing in appearance. Our on-line forms were updated, and new ones created. We all thank you for maintaining our professional image. Joan Bogaty and Karon Jarrard are both California Daughters. They work tirelessly to keep our membership informed with EXCELLENT contributions to our Calumet and Yearbook. And finally, Betsie Gricar, who works tirelessly to keep our Society database correct.

Governor General Glenn asks, "if there are no objections, due to the illness of our Recording Secretary General, I have appointed Tammy Mouliere, Recording Secretary Pro Tem for the Executive Committee". Hearing none, "Tammy Mouliere is appointed".

Governor General Mary Glenn calls for the Credential Committee report, and Ashley Barton gave the credentials report.

Ashley Barton requests: "Madam Governor General as Credentials Committee Chairman, I move adoption of the Credentials report." Governor General, "since this motion comes from a committee, no second is needed. Is there any objection to adopting the credentials report as given, hearing none the motion is adopted. We have a total voting strength of 51. Our Bylaws state that we must have 21 members present for a quorum. Therefore, a quorum is declared for the transaction of business".

Governor General Mary Glenn, "The Meeting Program was distributed, and you have had a chance to review it. Are there any corrections or additions?" Lynne Tate gave a correction that Laura Allen as Registrar was omitted. Martha Ann Whitt, "I make a motion for the adoption of the Meeting program as corrected". Barbara Allison seconded the motion. Governor General Mary Glenn declared the adoption following a voice vote.

Governor General Glenn, "Minutes of the April 6, 2023, Spring Committee Meeting were approved by committee and published. There being no corrections, the Minutes of the April 6, 2023, Spring Committee Meeting will be filed as printed".

Governor General Glenn, "With approval from the Membership, Wanda Samek, Rebecca West, and Sherrie Archer have been appointed to approve the minutes of the 35th Annual Council meeting. There being no objections the above names are appointed".

Recording Secretary Pro Tem, Tammy Mouliere read the recommendations from the Executive Committee. There are four recommendations.

1. Tammy Mouliere, "The Executive Committee recommends that all bills of the Continental Society be paid. Madam Governor General, I move the adoption of the recommendation. Since this is a

- recommendation from the Executive Committee, it requires no Second". Governor General Mary Glenn declared the recommendation adopted following a voice vote.
- 2) Tammy Mouliere, "That all acts of the Executive Committee and business conducted from 6 April 2023 to 16 of September 2023 be affirmed and ratified and approved by the members and made effective as official actions of the organization. I move the adoption of the proposed recommendation. Since this is a recommendation from the Executive Committee, it requires no Second". Governor General Mary Glenn declared the recommendation adopted following a voice vote.
- 3) Treasurer General, Shirley Arendt, presented the Proposed 2023-2024 Budget. Treasurer General "Madam Governor General, I move the adoption of the 2023-2024 budget as a recommendation of the Executive Committee". Since this is a recommendation from the Executive Committee, it requires no Second. Governor General Mary Glenn declared adoption of the recommendation following a voice vote.
- 4) Tammy Mouliere, "CSDIW Bylaws: In part Article XV Section Dues states "annual dues of the Continental Society shall be determined by the Executive Committee and payable to the Treasurer General by Aug 1....Therefore it is of the recommendation the Executive Committee #4a be added to the Standing Rule #4, stating members reaching the age of 90+ in good standing and have been a member for the last 5 years are no longer be required to pay General dues of \$10. State and or Chapters Societies may adopt their own Standing Rule. I move the adoption of the proposed recommendation. Since this is a recommendation from the Executive Committee, it requires no Second". Governor General Mary Glenn declared the adoption of the recommendation following a voice vote.

Governor General Glenn appointed Lora McDaniel as Timekeeper.

Reports of the Officers General, Committee Chairman General, State Governors, the reports of those not in attendance were filed.

There were more than 3 months since we met. There was no unfinished business.

Under new business, Jackie-Lynne Schulman made a Scholarship Motion," I move to increase the number of scholarships given in 2024 to five (5) for a total of \$15,000. Funds to come from the General Scholarship Fund Certificate of deposit. $4 \times \$2,500 = \$10,000$ and $1 \times \$5,000$ for a total of \$15,000". Shirley Arendt 2^{nd} the motion. Governor General Mary Glenn declared the adoption of the motion following a voice vote. Lynn Tate brought to membership the American Friends of Lafayette sponsorship. Lafayette 200 Reenactment tour and sponsorship on Panels with our Logo and name on Panels. There was a discussion. Karen Hall made motion, "To Sponsorship American Friends of Lafayette for a \$2,000.00 donation". It was 2^{nd} by Anne Garner. Governor General Mary Glenn declared the adoption of the motion following a voice vote.

Sue Moritz, Organizing Secretary General, raffled off an Indian Plate for \$5.00/playing card in which Governor General would call out a card and whoever had it won the plate. All proceeds go to General Scholarship Fund. Joyce Wold of Arizona won the Plate.

Reading of the by-law for the Nominating Committee by Recording Secretary General pro-tem Tammy Mouliere. ARTICLE X, SECTION 1 OF THE BYLAWS STATE: "A Nominating Committee of 3 members who are in good standing shall be elected during the Annual Council Meeting in the year preceding an election year. Nominations can be made from the floor. No more than 5 members may be nominated to serve on this committee. A nominee must give her consent to serve either orally or in writing. Section 2 States if there are 5 names then we need to have a ballot vote and the three receiving top votes will constitute the Nominating Committee. Section 3 states the Names of the Candidates are submitted to the Chairman no earlier than April 1 and no later than May 31 prior to the Annual Meeting in the Election Year so the names

can be included in the CALUMET".

Lynda Moreau nominated Helene Werner, Tammy Mouliere nominated Lora McDaniel and Helene Werner nominated Rebecca West. Jessianne Wells moves that the Nominating Committee be closed. Karen Hall moved that the committee be elected by acclamation. 2nd by Christine Napier the motion was approved.

Chaplain General Mari Noorai gave the Luncheon Table Blessing. The fork has been raised by Governor General Mary Glenn.

Governor General Glenn resumed the 35th Annual Council meeting at 12:52 p.m., the rituals were conducted earlier and will not be repeated.

Chaplain General Mari Noorai conducted a Memorial Service for those members who have passed. Pat Gallagher placed white flowers in a vase for those members.

Governor General recessed until the Banquet at 6:00 p.m.

Governor General welcomed all attending the 35th Annual Council Meeting. She called the session to order at 6:01 p.m."

The invocation and blessing were given by our Chaplain General, Mari Noorai. The following rituals were conducted, The Pledge of Allegiance to the Flag of the United States led by Corresponding Secretary General, Betsie Gricar, The American's Creed led by Historian General, Jackie-Lynne Schulman, Salute to the Banner of the Continental Society Daughters of Indian Wars-led by Organizing Secretary, Sue Moritz, The Object of the Continental Society-led by Treasurer General, Shirley Arendt, Colors of the Wind-led by Chaplain General, Mari Noorai.

Governor General Mary Glenn introduced the Head Table, Speaker Butch Walker, Alabama State Governor, Martha Ann Whitt, Recording Secretary General Pro Tem-Tammy Mouliere, Chaplain General, Mari Noorai and Historian General, Jackie-Lynne Schulman.

Governor General Mary Glenn recognized all the Honorary Governor Generals in attendance, Helene Werner, Karen Hall, Ann Garner and Shelby Ward. She thanked all the members attending.

Dinner was served and the fork was raised.

Martha Ann Whitt introduced the speaker. Butch Walker, he spoke on the Creek Indians and the State of Alabama. He has written 16 books and were on display. A Certificate of Appreciation was presented to our Speaker by Governor General Mary Glenn and Alabama State Governor Martha Ann Whitt.

Governor General Mary Glenn announced, the 2024 Spring Board meeting will be held at the Army Navy Club, Washington, D.C. on Thursday, April 4, 2024. Additional information and registration for this meeting will be in the Calumet. Tammy Mouliere announced an invitation to the 36th Annual Council Meeting in Austin, Texas.

Governor General Glenn thanked everyone for attending the 35th Annual Council Meeting in Huntsville, Ala. Chaplain General Mari Noorai delivered the Benediction. ALL held hands in a circle and sang Bless Be the Tie that Binds. led by Karen Hall

The meeting was adjourned at 8:03 p.m.

FIRST DEPUTY GOVERNOR -Lynda Moreau

Since being elected as 1st Deputy Governor in September, the Governor General has tasked me with establishing the public ancestor database online so that prospective members can see if their ancestor's service has already been documented.

As this officer reported at the Spring Board of Management meeting in Washington, D.C. in April of this year, approved ancestors listed in Books 1 and 2 of the CSDIW Ancestor Register have been completed and are on-line. Work on Book 3 has begun. At this point, I am halfway through Book 3. Book 3 has more names that Books 1 & 2 combined. The three books together contain Ancestor numbers 1 through 2350 and represent those that were approved 1988- 2020. There are well over 1000 names currently listed online with more being included every few days. This information includes the ancestor's name, the name of the spouse, the state where service was performed, and the membership numbers that have been approved on that ancestor.

I can only go by the information that is printed in the current Ancestor Registers. Occasionally the information is incomplete, especially on the earlier applications. Note that female ancestors are listed by their MAIDEN names, not their husband's name. Sometimes the spouse was unknown or the service description is rather nebulous and does not include the place of service. If you see an ancestor that doesn't have an application number listed, it means that for some reason they didn't make it into the book's index, so the application number was not provided in the printed Ancestor Roster. If your ancestor listing is incorrect or incomplete, please contact this officer so the information can be updated.

RECORDING SECRETARY GENERAL - Karon Jarrard

The Executive Committee met via Zoom at 5:00 pm (Texas time) on March 31, 2023, and again on April 16 prior to convening the Board of Management meeting.

This officer recorded minutes of the 35th CSDIW Spring Board of Management Meeting, held April 6, 2023, in Washington, D.C. The minutes, approved by Tammy Mouliere, Sue Moritz and Jane Hampton, are printed in the June 2023 *Calumet*.

This officer was authorized to revise the CSDIW directory of members posted on our website. The listing of all members is in alphabetical order and will be listed by state. This revision has been delayed and the directory was pulled from the site because of an access issue. The access issue has been corrected by Webmaster Beverly Baker and the directory has been reposted.

CORRESPONDING SECRETARY GENERAL -Betsie M. Gricar

This Officer would like to ask those submitting Change forms via snail mail to put an email address under their signature so that she can let you know she received your Change Form and has completed the request. She would also like to thank the chapters for keeping up with the changes of their members. These change forms are very important. Another duty of this officer is to send out notices at the request of the Governor General. State Governors should read these carefully as frequently Madam Governor is asking you to share the information with your members.

ORGANIZING SECRETARY GENERAL—Susan Moritz

This officer attended the April 2023 National Board Meeting in Washington, DC.

On July 22 this officer received a request to assist Gayle Gardner from Colorado. Gayle is interested in organizing a society in Colorado. She told me that her mother joined the society in 2016. A copy of the handbook was sent to her and pages were noted that would help her in organizing along with my phone contacts. The next day she responded and due to work overload she is not able to organize at this time but she is working on a member at large application.

This officer is looking forward to the meetings next year.

TREASURER GENERAL—Shirley Arendt

This officer continues to monitor chapters and states to ensure that the IRS 990N E-postcards are being filed on time. We continue to have difficulties with the State of Alabama and the Brushy Creek Chapter. We continue to work with the IRS to get these resolved. Alabama is in the process of changing their status from a foundation to a tax-exempt 501c(3). Alabama has filed taxes as a foundation for the period ending October 31, 2022. Brushy Creek does have a tax-exempt status which is current. We're just unable to file the 990N E -postcard. All other chapters and states are current through October 31, 2022.

The treasurer records were reviewed for the period of September 2022 through July 2023 by Sue Moritz and Barb Allison. Thank-you ladies for your handling of this!

Because the assets of CSDIW were all being held at Bank of America and had exceeded the \$250.000.00 threshold for FDIC insurance coverage, a Certificate of Deposit was opened in the amount of \$25,000.00 at US Bank.

The State of Georgia Secretary of State Annual Registration was completed on January 8, 2023.

Most of the dues have been collected for 2023-2024. We still have a few outstanding who are past due. The due date was August 1, 2023. Thank you so much to the first three chapters and states who submitted their dues early! They were as follows:

1st – Kennesaw Mountain 2nd – Arkansas 3rd – Arizona

The assets of CSDIW total \$257,016.99 as of August 24, 2023.

***We, as the selected Review of Books for the Continental Society Daughters of Indian Wars (hereinafter referred to as the CSDIW) have review the records of the Treasurer, Namely the account registers for checking, savings and investment Accounts and Bank Statements. We find the records to be in good order and their contents to appear reasonable. We have also reviewed the financial statements for the CSDIW, which summarize the records referred to above for the fiscal year ended July 2023. (Barbara Allison & Sue Moritz)

LIBRARIAN GENERAL— Joyce Wold

This officer was able to attend the April 2023 Conference in Washington, D.C. as Librarian General and as State Governor. Also, this officer was invited to send CSDIW Greetings as a National Officer and State Governor at DAR Arizona State Conference in May 2023. Our state meetings are now in person sharing the business time and guest speakers with New England Women and Daughters of the Colonial Wars. One of our members purchased a Calumet (Peace Pipe) from the Navajo Nation. We added the "Presentation of the Calumet" to our agenda. Arizona Society supports Schalorships, Governor General Project, and a local Junior College for Native American Students from the Reservations. As most States, we are increasing our Arizona Society membership bit by bit.

ASSISTANT REGISTRAR GENERAL-Karen Janczy

Since the report given at the 35th CSDIW Spring Board Meeting in April 2023 by this officer, sixteen member supplementals have been reviewed and verified, as of Aug 12, 2023; with a total of forty supplementals reviewed and verified after assuming the duties of the Assistant Registrar General in September 2022.

All supplementals have been scanned to a thumb drive as well as being saved on the Google drive. In addition, these records are also uploaded onto the DropBox "Approved Supplementals" folder, created and maintained by Registrar General, Laura Allen.

Updates have been provided to the First Deputy Governor for the website, as well as the Chairmen for the Awards, Calumet and Lineage Book committees. Award certificates were created and mailed to the Awards Committee Chairman.

Recommendations: Members and States must include the Membership Number on the supplemental form, and include a copy of all verified lineage society applications, , including CSDIW applications, as well as documentation for new information with the mailing. This officer does not have access to the original applications of every member or all of the supplementals that have been submitted to date to the Society. Original CSDIW applications will be scanned and saved in the Member's folder for future use.

SCHOLARSHIP CHAIRMAN –Leslie Vander Meulen Richards

Thanks to our generous members and our devoted National Officers, we were able to award three Scholarships to deserving young people this year. Fewer applications were received this year than normal, and this was unexpected due to the large number of inquiries and requests for applications this chairman received and answered. My appreciation goes to Shirley Arendt for her prompt attention and fast sending of the award checks to the three schools. The students always worry that their scholarship funds will arrive on time for registration, but Shirley kept our winners from that stress, so kudos to her.

The twelve valid applications came from 5 Navajo students, 1 Cree, 3 Cherokee, 1 Chippewa, 1 Tlingit-Haida of Alaska and 1 Oklahoma Seminole. The geographical make up of the applications is 1 each CA, NV, NM, MT, and ND; 2 from Alaska & MO and 3 from Arizona.

Winner of one of our \$2,500 awards: Miss Faith Wells of Missoula, Montana will be attending SUNY College of Environmental Science & Forestry to study to help her native people better manage and utilize their lands, crops and forests. She is a member of the Cold Lake First Nations (Cree) tribe. From her application: "My journey in the field of geoscience and environmental interpretation has provided me with a deep understanding of the challenges faced by Indigenous communities, particularly in terms of representation, access to resources, and educational opportunities." She will be one of only 15 tribal members nationwide who will graduate with a degree in geoscience. I think she will go far in helping her trial fellows in many ways!

The second winner of a \$2,500 award: Miss Justine Butterfield, of Winslow, Arizona, will be attending Haskell Indian Nations University in Lawrence, KS. She will be a Senior in elementary education and is a member of the Navajo Nation. I don't think I have to emphasize how badly our indigenous youth need good, well-educated teachers and school administrators. This young over-achiever has pages in small font of activities, awards and academic high honors, carrying a 3.951 GPA with all of her many many activities.

Our \$5,000 winner is Miss Morgan Elizabeth LaRoque of Moorhead, MN and a member of the Turtle Mountain Band of Chippewa Indians. Morgan will attend Concordia College, entering with a GPA of 3.72, to study to be a teacher in her indigenous environment. She began going to school with her grandmother, an English teacher on her reservation. Her grandmother was an amazing role model for many students and her grand-daughter too. She wants to "change the narrative about Indigenous students. I want to change the data regarding the high number of Indigenous dropouts." She is an athlete, award-winning musician and member

of several honor-bands, and a star honor student also. One of her references said, among a LOT else, "She is simply a pleasure to teach and a blessing to have as a part of my class." She is paying for her education on her own with multiple jobs, savings and scholarships. "If chosen ...[I would] become a future educator and teaching the next generation of Indigenous students that they are so capable of achieving their dreams."

SCHOLARSHIP PINS CHAIRMAN - Shari Worrell

All proceeds from the donations go towards two Native American Scholarships presented annually by CSDIW. One scholarship is for \$2,500, the other is for \$5,000. This is the only project of the Society that awards scholarships to Native American students

Small Pony pins are \$25, Feather pins are \$100, Tomahawk pins are \$200, Calumet pins are \$300, Chief pins are \$500 and Large Horse pins are \$1,000 (shipping and handling is included).

When ordering a pin please make your check payable to CSDIW (put Scholarship Pin donation on the Memo line). Scholarship pins are a nice way to honor or remember someone and help provide a scholarship to a Native American student.

The Scholarship Pin donation form is on the website. Once a donation is made the CSDIW Treasurer General notifies the donor of the amount they may claim as a charitable contribution based on the Society's 501(C)(3) non-profit tax exemption

As a reminder: Pins may be worn anywhere, anyplace. They may be worn on a lapel or on a sash but they may NOT be worn on the insignia ribbon.

The Arkansas Society Continental Society of the Daughters of Indian Wars welcomed Governor General, Mary Glenn to our August 2nd meeting, held at the Chenal Country Club, Little Rock, AR. The event was well attended. Madam Governor General delivered the program. Following the meeting AR Society Governor, Kay Tatum took Governor Glenn on a tour of Little Rock, which included historic Mount Holly Cemetery, circa 1843, and the gravesite of Quatie Ross, the wife of Chief John Ross. Quatie died during the Trail of Tears as their steamer neared Little Rock. In 2003 the Arkansas Society CSDIW placed a marker at her gravesite. Other stops included the "Designing Women" house, the Villa Marre, which served as the backdrop for the Sugarbaker house in the television series.

Governor Glenn was a guest of the Empress of Little Rock during her visit to Little Rock. The circa 1888 Victorian mansion, one of Little Rock's most beautiful historic treasures, is an award-winning Bed and Breakfast.

During the meeting, Governor General, Mary Glenn was presented with an Arkansas Traveler certificate. The popular song was written by Sanford Faulkner and the painting portrayed on the certificate by Edward Payson Washburn. Both interred at Mount Holly Cemetery.

March 31, 2023, Little Rock experienced an F4 tornado that was on the ground for more than 34 miles. The devastation destroyed many neighborhoods. The Arkansas Society CSDIW delivered an SUV full of toiletries, underwear, tee shirts and assorted clothing, plus a cash donation to City Center. This facility, an outreach of Immanuel Baptist Church was an all- inclusive resource for tornado victims, completely manned by volunteers, the AR National Guard and Little Rock Police. The American Red Cross and FEMA were available on site to assist.

The Arkansas Society of the Continental Society Daughters of Indian Wars are dedicated in supporting our community through volunteer hours at local cemeteries and supporting the local veterans' facilities.





CALIFORNIA – Governor Shirley Vandebeck

The year 2022-2023 has ushered in a much needed wet winter; a brief hot summer; a very wet summer storm, and a slow return to "in person" meetings for lineage societies. However, we continue to approve new member applications.

The land has been a sacred place to the California Native Americans for centuries.

We were privileged to have the Governor General, Mary Glenn, attend our annual meeting by Zoom. She won the raffle prize of a handmade Indian Maiden.

This officer's symbol during her term is the colorful dragonfly. The pin shown left is available for purchase at \$10.00. All proceeds from sales will be sent to the Inter-Tribal Sinkyone Wilderness Council

DISTRICT OF COLUMBIA– Governor Christina Marie Dickens Harle

Our August meeting was held at the Butterflies & Wishes Tea and Sweet shop with speaker Lucia St. Clair Robson. She spoke on the background of her book about Cynthia Ann Parker, called Riders in the Wind.

We have welcomed 8 new members and one supplemental. One member was reported deceased in 2022, giving the State Society a total of 39 members. Eleanor Roeder died 2 May 2022. She organized the District of Columbia State Society and was member #1. Register Nicki Burch is currently working with 7 prospective members.

This sheet is accessible for all these officers and information is kept up to date with new members added; address changes entered and deaths recorded in real time. It is proving to be a huge success.

In a project initiated by Past State Governor Linda Robinson, we are continuing to sell Navajo Code Talker Pin pins to raise money for the Navajo Water Tank Project. To date the Georgia Society has purchased four water tanks from the proceeds of these pins.

The Tate Administration is planning a marker in Marion County, Georgia, near the Creek village of Cusseta where the Creeks began their march on the Trail of Tears. A pin was created to raise money for the marker inspired by the Creek Trail of Tears Monument at Ft. Mitchell, Al. The Indian Culture Center at the fort offers this description "The monument was designed to symbolize the sacred fire of the Creek Nation, which here last burned on original Creek lands". We have these pins for sale and 10% of the sale of each pin goes toward the General Scholarship Funds.

On October 7, the Indian Springs Chapter will mark the Indian Springs Hotel which was built in 1823 by Chief William McIntosh. It is the only known ante-bellum mineral springs hotel still standing. The marking will be celebrated with high tea that afternoon.

This officer is proud to report that the six chapters in Georgia continue to thrive. Our state registrar reports that we have added 10 new members this year, for a total of 158 members.

ILLINOIS-Governor Kathy Carey

The Illinois State Society met last September 17, during Illinois's Heritage Weekend.

A new slate of officers was installed.

On March 8, 2023 the Society met at a tri meeting with John Kinzie Chapter, USD 1812 and the Illinois State Society, Dames of the Court of Honor. There was a joint Invocation, Pledge of Allegiance to the Flag of the United States of America, and the American's Creed. The B.A. Church, past President read the Object of the Society.

It was decided to wait until the next year to issue a yearbook.

During New Business it was decided to donate the large flag with pole and base. One of our members volunteers at the Abraham Lincoln Cemetery and said they could use it.

KENTUCKY—Governor Pam Godwin

The Kentucky Society Continental Society Daughters of Indian Wars held their bi-annual meeting on Thursday, December 7, 2023 at historic Woodford Inn in Versailles, KY. The Society meets jointly with Jamestowne Society Wilderness Road Company and the Kentucky Branch Huguenot Society Founders of Manakin in the Colony of Virginia. We certainly have a collaborative spirit with these groups regarding Native Indian history and heritage from the beginnings of America's story and European settlement.

The Kentucky Society is excited to share with the National membership a worthy American Indian heritage preservation project underway here in Kentucky that we have funded. We encourage you to learn about this worthy opportunity and share the story.

The Choctaw Indian Academy was established at Blue Spring here in Scott County, Kentucky to educate young braves at the request of then sitting Kentucky United States Senator Richard Mentor Johnson. The school operated from 1825 to 1845, its story of endearing local and national importance. The boarding school began with 21 young braves and grew to accommodate 188 students from 16 tribes including the Creek, Pottawatomie, Cherokee, and Osage. The education received there was with such great merits that even local sons attended making it truly one of the nation's earliest interracial schools. On the site of the Academy exists one of school's dormitories, a three-story, dry-laid stone building erected in 1825. It needs preservation attention and dollars to complete the rehabilitation work. It is such a vital part of Choctaw Nation history that their Chahta Foundation offered a \$9,600 grant towards a \$300,000 to \$400,000 estimate for roof construction and stabilization to keep history from disappearing.

Kentucky Society members hope that you will do a bit of online reading at https://ohiomemory.org/digital/collection/p16007coll27/id/10821/ and learn about this school, a forgotten educational experiment with Indians

We are working towards a springtime fieldtrip to the historic site; it lies only 18 miles from where we gathered today.

LOUISIANA—Elizabeth Sewell

She has shepherded three new member applications and has one prospective member with whom she is working. Additionally, she has assisted one member with three supplementals and this same member has three more supplementals pending.

Our chapter recently presented a \$500 scholarship to a native American high school senior from a local high school who plans to major in biology in order to start his journey in medicine.

Also, our chapter has purchased at least eight of the President General's pins and has donated \$100 towards her UNITY project.

Our members are involved on the national board and two national committees.

Additionally, we held a Remembrance Day and Grave Marking the Louisiana Society held in honor or Rosalie (Houma) Courteaux Billiot on Saturday, November 18, 2023 at the Dugas Cemetery in Montegut, Louisiana. Lynda Moreau current 1st Deputy Governor General of the national organization is a member of the Natchitoches Indian Nation. Governor General, Continental Society Daughters of Indian Wars, Mary Glenn was in attendance. Also in attendance was Adam Crappel, Vice Principal Chief of the United Houma Nation. Members of the chapter included the Past State Governors, Lynda Moreau and Patricia Gallagher; the current State Governor, Elizabeth Sewell; Connie Gaines and Sherry Fonseca, Louisiana State Society members of United Houma Nation; Rena Labat and Lora McDaniel, Louisiana Society officers, and member Fairy Waters. About 50 men, women, and children of the United Houma Nation, many of whom are descendants of Rosalie Billiot, were also in attendance.

VIRGINIA—Governor Karen L. Pogoloff

The Virginia Society Daughters of Indian Wars meets twice a year, in September and February. The current board was sworn in on Thursday, September 8, 2022, at the historic Hanover Tavern in Hanover, VA. Outgoing Governor Donna C. Hall conducted the installation of officers and presented this Governor with the Governor's sash, insignia, and gavel.

This Governor held a Board Meeting on December 14, 2022, to discuss plans for the next two years. The Governor's project supports historic preservation and education focused on the tribes of Tidewater Virginia. The first donation was to the Virginia Tribal Education Consortium. VTEC facilitates accurate Virginia Indian history, sovereignty, cultural awareness, and educational opportunities. It is a part of the 501(c)(3) Tribal Education Agency created by the seven federally recognized Indian Nations across Virginia.

The spring meeting was held on Thursday, February 23, 2023, at the Westminster-Canterbury of the Blue Ridge in Charlottesville, VA. Deputy Governor Cheryl DeVine-Holick gave a program about her Indian ancestry, with a focus on her ancestor George Stiggins, a Creek Indian half-blood living in Alabama, raised in the white culture by his father, an English trader. His mother was a full blood of the Natchez tribe, part of the Creek Confederacy.

This Governor was honored to represent the Virginia Society at the Virginia DAR State Conference on Friday, March 17, 2023, at the invitation of State Regent Laurie Parker Nesbitt.

We will next meet on Saturday, September 30, 2023, at Mechanicsville, VA, for the fall meeting, with a trip to the Chickahominy Fall Festival and Pow Wow at Providence Forge, VA planned for the prior weekend.

SPECIAL INTEREST ARTICLE FROM LOUISANA STATE MARKING

UNITED HOUMA NATION- HOUMA, LOUISIANA

- Houma is the Choctaw word for red. Their emblem was a red crawfish.
- The first known historical record of the Houma tribe was that of LaSalle in 1682 along the Eastern Bank of the Mississippi river as he passed the Houmas village but did not stop to visit them. In 1699 the Houmas were visited by D'Iberville which started the tribe's friendship with the French. Their tribe was located where Angola Penitentiary is today in Angola, Louisiana, 55 miles north of Baton Rouge along the Mississippi River...
- By this time the Natchez tribe, 66 miles north of the Houma was partnering with the English and the Houma tribe was partnering with the French. This meant conflict. Between this conflict, conflicts between European colonies, a battle with the Tunica, and the effects of foreign disease the tribe was forced to leave that area and began a southward migration in 1706. Some of the tribe settled near Bayou St. John and some continued on to Bayou Lafourche (Donaldsonville).
- Around 1775 during the time of the Acadian exile from Canada, the European and French populations
 were putting severe pressure on the native village so they began their migration into lower LafourcheTerrebonne.
- In 1793, Judice a plantation owner near Bayou Lafourche reported a Houma Nation forming of no more than 90 persons. 15 were in a village near Cantrelle's Plantation, 17 in a village near Verret's Plantation and 58 near Judice's plantation which included 13 men, 22 women and 23 children.

- On April 30, 1803, Spain and France signed a treaty making Louisiana a territory of the United States. President Thomas Jefferson appointed Dr. John Sibley as Indian agent for the region. Unfortunately for the Houma, Sibley showed no desire to visit any villages in the swamps of southern Louisiana. This left the tribe without any official representation from the federal government which could have changed the recognition for the tribe today.
- In 1803 the leadership of the Houma tribe was under Rosalie Courteau daughter of Indian Chief Joseph Houma Courteau. She was married to Jacques Billiot who allegedly served in the War of 1812. They had seven children. The Houma village was located on Bayou Cane in Houma. Rosalie and Jacques worked hard to hold the tribe together due to the pressure for more land by white immigrants. She purchased large areas of land for her people.
- The Houmas and the new white immigrant settlers had many conflicts until one day, Rosalie's house was burned and the Houma Tribe fled down Bayou Terrebonne where they could independently maintain their Indian ways of life, language, medicine, arts, traditions and ceremonies. Tribal members were farmers, fishermen and trappers.
- By 1850 the Tribe settled deep in the inaccessible swamplands of lower Terrebonne.
- On April 11, 1878, at age 83 Rosalie applied for Widow's Pension for Jacques who served in the War of 1812. Her application was rejected a year later on July 14, 1879 on the grounds of no evidence of him being on muster rolls for either the Lafitte, Gambi or Thibodaux companies. She, however, had an affidavit from neighbors proving his service. Etienne, Jacque's brother's, wife Manette Renaud Billiot was also denied a Widow's Pension because she did not have proof of their marriage. At that time, because she was white and he was Indian, it was against the law to marry a colored person. They lived together as husband and wife for almost 20 years.
- In 1885, Rosalie Courteau died at the age of 90 (born in 1795). Rosalie was perhaps the greatest tribal leader through her leadership and courage during a very turbulent period in the Houma history.
- With a community of 1200 at the beginning of the 20th century, only about a ½ dozen people could read or write. Missionaries came into the tribe to assist with schooling.
- Not a weekend went by without balls or parties, poker games, target shooting, pirogue races and wrestling. Alcohol was not a part of tribal life because this would have represented a loss of purity in the tribe, and thus drinking was not allowed.
- With the discovery of oil and gas in the 1930's, the Houma People became vulnerable once again. Unable to read or write and speaking only their own Houma/French language, the Houma Tribe was prey for land developers and oil and gas companies who recognized the value of their property. Because they could not read the leases and contracts, many were ultimately cheated out of their land.
- In the 1950's Indian students were educated to the 8th grade. In the 1960's Indian students were still outsiders to the public high schools.
- It wasn't until the Civil Rights Act of 1964 when public schools were opened to the Houma children. The white color barrier remained unbroken for many years so many children went to either a mission school or had to get special permission from the Bishop or public school officials to attend school.
- Today, there are over 19,000 Native Americans as members of the United Houma Indian Nation.

REQUIREMENTS FOR APPROVAL of an APPLICATION OR SUPPLEMENTAL

- 1. All names, dates and locations listed must be documented. Vital records are required for the first three generations (unless using an approved application from another society (see 5 below).
- 2. The link is vital. Each connection between generations must be documented.
- **3.** Tradition or family lore will not be accepted as proof.
- **4.** Undocumented sources will not be accepted.
- 5. Other organizations may have accepted application papers on the line presented, but CSDIW may not be able to accept it without proper documentation. Those organizations may have extensive libraries available to research application papers, but CSDIW does not. Approved papers from other societies may be accepted at the discretion of the Registrar. If submitting an approved application from another society, please do NOT list that society application as "proof" on the CSDIW application. Simply copy the proofs from the other approved application EXACTLY at each generation to the CSDIW application.
- **6.** Please do not send extra proofs. One documented source is sufficient.
- 7. If an original document is difficult to read, it should be transcribed and the typed transcription attached to the copy of original document. Information from FindAGrave is not acceptable as proof unless it includes a CLEAR photograph of the gravestone in question.
- **8.** Please underline only pertinent information with a red pen or pencil, using a ruler. No highlighters. Write the applicable generation number in the margin by the information. If you are unable to underline, place an arrow in margin pointing to pertinent information.
- 9. Applications will be not be processed from 2 April through 25 April of each year. The cutoff for the processing of applications will be three weeks before Annual Council.
- 10. Applications will be processed twice a month (perhaps sooner as time/volume allows). You must provide the telephone number/email address of each applicant.
- 11. If the Registrar General has any questions, she would like permission to email you and/or the prospective member. If this is acceptable, please inform her when you send the application and include the Registrar's email address.
 - a. Always provide three (3) copies of the original application. At least one must have original signatures in black ink.
 - b. Please provide the newspaper name, and page number from the newspaper banner. If not available please write the name of the newspaper and date.
 - c. All applications MUST be printed front to back on both sides of the paper. Papers submitted on 4 sheets will be returned.
